- 2. As per the provisions of the Environment Impact Assessment (EIA) Notification, 2006, the above-mentioned project/activity is covered at schedule no. 3 (a) Metallurgical industries (ferrous and nonferrous) & schedule 1(d) thermal power plant under Category "A" of the schedule of the EIA Notification, 2006 and appraised at Central Level.
- 3. The proposal cited above was considered in 46<sup>th</sup> meeting of Re-Constituted Expert Appraisal Committee (Industry-1 Sector) held on 11-12<sup>th</sup> October, 2021 and further reconsidered in its 49<sup>th</sup> meeting held on 16-17<sup>th</sup> December, 2021. - The EAC, in its 49th meeting of the Re-constituted EAC (Industry-I) held on 16-17th December, 2021, based on information & clarifications provided by the project proponent and after detailed deliberations recommended the proposal for grant of Environment Clearance subject to stipulation of specific and general conditions as detailed in the paragraph given below.
- The MoEF&CC has examined the proposal in accordance with the Environment Impact 6. Assessment (EIA) Notification, 2006 & further amendments thereto and after accepting the recommendations of the Expert Appraisal Committee (Industry-1) hereby decided to grant Environment Clearance for instant proposal of M/s. Ramgarh Sponge Iron Private Limited



under the provisions of EIA Notification, 2006 subject to the following specific conditions and general conditions:

### A. Specific condition

- i. Particulate matter emission from all the stacks shall not exceed 30 mg/Nm<sup>3</sup>.
- ii. Green belt shall be developed in 34% of the total area all along the periphery of the plant with a density of 2500 sapling per hectare as committed by the PP.
- iii. 2488 KLD water shall be sourced from Damodar River for the proposed expansion. No ground water abstraction is permitted.
- iv. 100 % solid waste generated in the facility shall be utilized.
- v. All stockyards shall be having impervious flooring and shall be equipped with water spray system for dust suppression. Stock yards shall also have garland drains to trap the run off material.
- vi. Slip roads shall be provided at the gates and along crossings on main roads to avoid traffic congestion.
- vii. Performance monitoring of all Pollution Control Devices shall be carried out annually and report submitted to MoEF&CC, Regional Office.
- viii. All internal and connecting road to the Highway shall be black topped/concreted with suitable load in term of Million Standard Axle (MSA) as per IRC guidelines.
  - ix. Rain Water harvesting shall be implemented as per the action plan submitted in the EIA report.

### B. General conditions

### Statutory compliance:

The Environment Clearance (EC) granted to the project/ activity is strictly under the i. provisions of the EIA Notification, 2006 and its amendments issued from time to time. It does not tantamount/ construe to approvals/ consent/ permissions etc., required to be obtained or standards/conditions to be followed under any other Acts/Rules/Subordinate legislations, etc., as may be applicable to the project.

#### Air quality monitoring and preservation II.

- The project proponent shall install 24x7 continuous emission monitoring system at process stacks to monitor stack emission as well as two Continuous Ambient Air Quality Station (CAAQS) for monitoring AAQ parameters with respect to standards prescribed in Environment (Protection) Rules 1986 as amended from time to time. The CEMS and CAAQMS shall be connected to SPCB and CPCB online servers and calibrate these systems from time to time according to equipment supplier specification through labs recognised under Environment (Protection) Act, 1986 or NABL accredited laboratories.
- The project proponent shall monitor fugitive emissions in the plant premises at least ii. once in every quarter through laboratories recognized under Environment (Protection) Act, 1986 or NABL accredited laboratories.
- Appropriate Air Pollution Control (APC) system shall be provided for all the dust iii. generating points including fugitive dust from all vulnerable sources, so as to comply prescribed stack emission and fugitive emission standards.
- The project proponent shall provide leakage detection and mechanized bag cleaning iv. facilities for better maintenance of bags.
- Recycle and reuse iron ore fines, coal and coke fines, lime fines and such other fines v. collected in the pollution control devices and vacuum cleaning devices in the process after briquetting/ agglomeration.



- vi. The project proponent shall ensure covered transportation and conveying of ore, coal and other raw material to prevent spillage and dust generation.
- vii. The project proponent shall provide primary and secondary fume extraction system at all melting furnaces.
- Design the ventilation system for adequate air changes as per prevailing norms for all viii. tunnels, motor houses, Oil Cellars.

# III. Water quality monitoring and preservation

- The project proponent shall install 24x7 continuous effluent monitoring system with respect to standards prescribed in Environment (Protection) Rules 1986 (G.S.R 414 (E) dated 30th May 2008; G.S.R 277 (E) dated 31st March 2012 (applicable to IF/EAF): S.O. 3305 (E) dated 7th December 2015 (Thermal Power Plants) as amended from time to time and connected to SPCB and CPCB online servers and calibrate these system from time to time according to equipment supplier specification through labs recognised under Environment (Protection) Act, 1986 or NABL accredited laboratories.
- Sewage Treatment Plant shall be provided for treatment of domestic wastewater to ii. meet the prescribed standards.
- The project proponent shall provide the ETP for effluents of rolling mills to meet the iii. standards prescribed in G.S.R 277 (E) 31st March, 2012 (applicable to IF/EAF) as amended from time to time.
- Garland drains and collection pits shall be provided for each stock pile to arrest the iv. run-off in the event of heavy rains and to check the water pollution due to surface run off.

# IV. Noise monitoring and prevention

Noise quality shall be monitored as per the prescribed Noise Pollution (Regulation and Control) Rules, 2000 and report in this regard shall be submitted to Regional Officer of the Ministry as a part of six-monthly compliance report.

### **Energy Conservation measures** V.

Energy conservation measures may be adopted such as adoption of solar energy and provision of LED lights etc., to minimize the energy consumption.

# VI. Waste management

- Used refractories shall be recycled as far as possible. i.
- Kitchen waste shall be composted or converted to biogas for further use. ii.

### VII. Green Belt

The project proponent shall prepare GHG emissions inventory for the plant and shall submit the programme for reduction of the same including carbon sequestration including plantation.

# VIII. Public hearing and Human health issues

- Emergency preparedness plan based on the Hazard identification and Risk Assessment (HIRA) and Disaster Management Plan shall be implemented.
- The project proponent shall carry out heat stress analysis for the workmen who work ii. in high temperature work zone and provide Personal Protection Equipment (PPE) as per the norms of Factory Act.

Occupational health surveillance of the workers shall be done on a regular basis and iii. records maintained.

# IX. Environment Management

- The project proponent shall comply with the provisions contained in this Ministry's OM vide F.No. 22-65/2017-IA.III dated 30/09/2020.
- The company shall have a well laid down environmental policy duly approve by the ii. Board of Directors. The environmental policy should prescribe for standard operating procedures to have proper checks and balances and to bring into focus any infringements/deviation/violation of the environmental / forest / wildlife norms / conditions. The company shall have defined system of reporting infringements / deviation / violation of the environmental / forest / wildlife norms / conditions and / or shareholders / stake holders. The copy of the board resolution in this regard shall be submitted to the MoEF&CC as a part of six-monthly report.
- A separate Environmental Cell both at the project and company head quarter level, iii. with qualified personnel shall be set up under the control of senior Executive, who will directly to the head of the organization.

#### Miscellaneous X.

- The project proponent shall make public the environmental clearance granted for their project along with the environmental conditions and safeguards at their cost by prominently advertising it at least in two local newspapers of the District or State, of which one shall be in the vernacular language within seven days and in addition this shall also be displayed in the project proponent's website permanently.
- The copies of the environmental clearance shall be submitted by the project ii. proponents to the Heads of local bodies, Panchayats and Municipal Bodies in addition to the relevant offices of the Government who in turn has to display the same for 30 days from the date of receipt.
- The project proponent shall upload the status of compliance of the stipulated iii. environment clearance conditions, including results of monitored data on their website and update the same on half-yearly basis.
- The project proponent shall monitor the criteria pollutants level namely; PM<sub>10</sub>, SO<sub>2</sub>, iv. NOx (ambient levels as well as stack emissions) or critical sectoral parameters, indicated for the projects and display the same at a convenient location for disclosure to the public and put on the website of the company.
- The project proponent shall submit six-monthly reports on the status of the compliance of the stipulated environmental conditions on the website of the ministry v. of Environment, Forest and Climate Change at environment clearance portal.
- The project proponent shall submit the environmental statement for each financial year in Form-V to the concerned State Pollution Control Board as prescribed under vi. the Environment (Protection) Rules, 1986, as amended subsequently and put on the website of the company.
- The project proponent shall inform the Regional Office as well as the Ministry, the date of financial closure and final approval of the project by the concerned authorities, vii. commencing the land development work and start of production operation by the project.
- The project proponent shall abide by all the commitments and recommendations made in the EIA/EMP report, commitment made during Public Hearing and also that during their presentation to the Expert Appraisal Committee.

- No further expansion or modifications in the plant shall be carried out without prior ix. approval of the Ministry of Environment, Forests and Climate Change (MoEF&CC).
- Concealing factual data or submission of false/fabricated data may result in X. revocation of this environmental clearance and attract action under the provisions of Environment (Protection) Act, 1986.
- xi. The Ministry may revoke or suspend the clearance, if implementation of any of the above conditions is not satisfactory.
- The Ministry reserves the right to stipulate additional conditions if found necessary. xii. The Company in a time bound manner shall implement these conditions.
- The Regional Office of this Ministry shall monitor compliance of the stipulated xiii. conditions. The project authorities should extend full cooperation to the officer (s) of the Regional Office by furnishing the requisite data / information/monitoring reports.
- Any appeal against this EC shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.
